#### On the Bright Side

When a "Black Swan" event strikes, either by financial markets, natural disasters or a pandemic, such as COVID-19, the stock market goes wobbly, lenders pull back, super markets and Big Box retailers such as Costco and Target are jammed, schools close and life as we know it is interrupted – to say the least. This "super-flu" is serious, and we all know that now. Just when it will peak in our country is unknown, but the health professionals and officials are trying to "flatten the curve" of the spread of the virus, to try to prepare and ensure adequate health resources are available to those in need. Hence, the request to halt gatherings, prohibit travel from hot spots, and implement social distancing efforts. To temper the outbreak might lengthen the timeframe of the spread, but would allow for more preparedness and perhaps even a vaccine to prevent the illness for those now and in the future.

How long this interruption will last is also unknown – and uncertainty generates fear. But there are bright spots:

- 1. With a few caveats, we are coming together as a nation to ensure efforts to implement best practice strategies in coordination with national, state and local municipalities; Our Governor is leading the way by example being honest about the cooperation California is receiving from the President and his administration;
- 2. New research and development using government funds and private companies will develop testing, vaccines, medicines for treatment, not to mention funds for more training of healthcare personnel and construction of much needed emergency and acute care facilities to ensure those requiring hospitalization can get it;
- 3. We are breaking the logjam of regulations that impede progress on the medical side for all of the items in #2 above to proceed;
- 4. And, if we are smart, we are probably eating more meals at home, spending more time with people we live with, and developing a keener understanding of the freedoms we enjoy, how fragile life is, and how much that happens is unpredictable an beyond our control.

### The Key: Isolate, Trace and Contain

**And more testing is becoming available**, thanks FDA's emergency authorization for COVID-19 tests kits by Roche, a pharmaceutical giant and Thermo Fisher, US scientific instrument maker. It's being reported that Roche can manufacture up to 3.5 million test kits per months, with Thermo Fisher to ship 1.5 million tests by this week (mid-March) with the ability to produce 5 million tests per month by early April.

Locally, Quest in San Juan Capistrano provides a test if *requested from your healthcare provider*. Don't go into their labs. From Quest Website: "The Quest Diagnostics test for COVID-19 is a qualitative, molecular test to detect RNA from SARS-CoV-2, the virus which causes COVID-19. Our test was internally developed and validated according to CLIA requirements. The independent review of this validation by the FDA is pending. **This test does not require confirmation by CDC prior to reporting results." Results are usually within 2 days. Other private companies and Universities are also engaged in testing and establishing available locations for doing so. Drive in testing has been reported as being available soon in many counties.

But the more test, the more cases of many who are experiencing only mild symptoms. So relax, and adopt perspective; most people will not even know they are infected, hence the need to distance, but not panic.

# **Biotech and Biomed Leading the Way**

The resurgence of Biotech and Biomed industries making news is heartening. Having travelled statewide visiting companies, community colleges, universities as well as having worked with trade associations, I have seen California leading the way with hubs in San Diego, Orange, Los Angeles and San Francisco Counties where major industry leaders and venture capitalists work collegially with universities and start ups. Biotech and Biomed industries proliferate here and are the wave of the future for our state and the nation, not only for access, cures, vaccines, and devices that can make healthcare more available, more reliable and more affordable over time, but they also offer great careers for all levels of education from manufacturing to professional fields.

As reported in the OC Register, the US Department of Health and Human Services is awarding \$679,000 in federal funds to a company in Cypress, California, to develop a diagnostic test to detect the virus in just 1 hour. The Wall Street Journal has been a great source of information and in particular, a video on the modern method for creating vaccines. Vaccines of old required that some of the foreign "invader" be injected into the patient, so that an antigen (immunity) could be formed. The risks are inherent in the method of creation. But one of the marvels of biotech is that using Rapid Response Platforms using DNA/RNA coding, your body can create its own antigen, to recognize and fight off the virus (Messenger RNA produce antigen proteins). Amazing! Clinical trials are underway by Moderna, Inc. and if successful, a vaccine could be available in 18 months. I understand that you may fear that you could be quarantined, which is reasonable, but groceries can be delivered to your doorstep and water from the tap is still fine to drink; be reasonable. As for toilet paper (another hot commodity) use your judgment and don't hoard. We will make it through this, better than most nations because we are so diverse, free-thinking and talented, and I believe we will build a better and stronger community, state and nation because we will work together to meet the challenge.
